1 Warranty Conditions

Each shopping and transportation trolley will be reviewed by the company J.D. Geck GmbH with high diligence before delivery and subject to final inspection. If there is a reason for complaint in spite of everything, our approach is as follows.

If not otherwise contractually agreed, the warranty period starts with the date of delivery and expires at the end of 24 months.

The defects observed have to be reported to the company J.D. Geck GmbH within 14 days of inspection, with the help of your completed return form.

The warranty covers defects which are verifiable due to improper materials or workmanship faults.

The costs occurred by fault correction, as well as related transport and installation costs, are covered by the company J.D. Geck GmbH. Further claims are excluded.

Faulty parts, which get replaced, have to be returned into the property of the company J.D. Geck GmbH. For the newly inserted parts a new 24-month warranty is granted. However, these repairs do not let restart the warranty period for the entire product.

Any repairs or services have to be executed by the company J.D. Geck GmbH or by authorised specialists. In case of inobservance to comply the complete warranty cannot be assumed.

In case of inobservance to follow the product instructions, inappropriate or improper use, faulty installation (by third parties) or damage caused by a foreign plot, no claim for warranty exists.

2 Safety

Before using read this manual through very carefully!

2.1 DIN 1929-1 ; GS mark

Our shopping trolleys are manufactured according to the specifications of the standard DIN 1929-1. During the production these specifications strictly get observed in all our models. You can therefore be assured that our shopping trolleys at any time comply with the requirements of DIN 1929-1 and comply at all times the same standard.

Please note!

Our GS marks shall apply to the TÜV (Technical Inspection Agency) approved shopping trolleys whose standard is defined for each GS mark. If a shopping trolley deviates from the standard due to modifications, the certification expires and must be re-applied with costs.

2.2 Use

 Geck shopping trolleys are determined solely for the transportation of shopping in selfservice markets.

2.3 Safety relevant training of personnel

- Your staff must be available to end customers to advise and assist them in the handling of shopping trolleys. For this reason, train your personnel if, for example,
- Safety belts are not used for the baby seat
- Trolley baskets are overloaded with drinks crates
- Goods are transported on the seat
- Customers are riding the moving pavement/ramp with trolleys that are unsuitable
- Children are hanging on the side of the shopping trolley
- The trolley (basket) is used for the transportation of a child
- Trolleys are not used according to purpose

2.4 Areas of use

- Geck shopping trolleys are designed for use indoors in self-service stores and in the customer car parks attached to such.
- The use of Geck shopping trolleys on moving pavements/ramps is only permitted with specially designed Geck shopping trolleys for moving pavements/ramps.
 The regulations of professional unions must be observed along with local construction and safety regulations and the regulations of health and supervisory authorities.
- Geck shopping trolleys are only suitable for use on flat surfaces.



2.5 Safety notes

 A sign (corresponding to Figure 1) must be permanently and visibly installed close to the entrance of the moving pavement/ramp. This pictogram in white on a green background should be at least 80 mm x 80 mm and carry the following instruction: "Always hold the handle firmly".

• Examples for additional signs in the market, which are to be installed by the market itself:







- Ensure that babies and small children are only transported under supervision in the seats or special transportation aids.
- Move lines of trolleys at a walking pace using two people, one at the head and one at the tail of the line.
- Regularly check a mounted baby seat or baby safe surface for loose screw connections or broken brackets.
- Regularly check the functionality and safety of the trolleys and document these checks (checklist).
- Only use original Geck replacement parts.
- In the event of subsequent modifications to the trolley (e.g. by the addition of accessories), the liability of Geck GmbH expires. An exception: Conversion by a specialist authorised by Geck.
- When distributing road salt, avoid direct contact of the salt with the shopping trolley in order to prevent salt corrosion.
- Do not use damaged or defective shopping trolleys. Have these repaired if necessary.
- Only use Geck shopping trolleys according to their intended purpose.
- Prevent risks and risk of injury to people.
- Park shopping trolleys outdoors only in the intended parking boxes, since exposed parking violates hygiene regulations.

(i) Observe the manuals and instructions of the conveyor system for transporting on the conveyor system.

2.6 Warning notes

Warning: Against contamination of the basket by carried children or animals. Consequence: Contamination and introduction of germs due to dirt in the basket.

Lensure that, for hygienic reasons, neither children nor animals are transported in the basket.

Warning: Shopping trolley rolling away.

Consequence: Damage to objects, for example, parking cars, risk of injury to people, in particular, small children in the child seat (baby seat).

Make sure that shopping trolley is always held firmly when in use.

Warning: Positioning of shopping on the child seat when a child is sitting in the seat Consequence: Crushing, injury or strangulation of the child.

- Ensure that the child seat is used for a child or for shopping.
 Warning: Against improper use of the shopping trolley.
 Consequence: The shopping trolley may tip, damage objects or injure persons.
- ! Ensure that the shopping trolley is only used correctly.
- ! Ensure that the shopping trolley is not used on escalators.
- ! Make sure that the only moving pavement/ramp suitable shopping trolleys with Geck conveyor castors are used on moving pavement/ramps.
- ! Ensure that the shopping trolley is not lifted, tipped or carried.
- ! Make sure that trolleys are always pushed in a controlled way and are not pushed away or permitted to roll down slopes without guidance.
- ! Make sure that no goods that protrude from the sides are transported in the shopping trolley.

Warning: The basket flap or the child seat flap of the shopping trolley is moveable to enable the trolleys to be pushed inside one another.

Consequence: Crushing and injury risk by the unfolding of the basket flap or child seat flap

- ! When removing and returning the shopping trolley, do not reach laterally into the basket.
- ! When returning the shopping trolley, ensure that children do not reach into the basket.
- ! Make sure that babies are removed from the baby seat before pushing the shopping trolleys into one another.


Warning: Hanging onto the side of the shopping trolley.

Consequence: Tipping of shopping trolley, damage to objects, risk of injury to people, to small children in the child seat, baby seat and baby safe and to the person hanging on the side.

Lensure that no one, in particular children, hang onto the side of the shopping trolley.


3.3 Replacing the castors.


3.3.1

Exchange, attachment with micro-encapsulated hexagonal socket-type screw



3.3.2 Trolley with lockable castor





For releasing move the upper lever in travel direction. For locking move the pedal downwards.

3.4 Replacing the handles

Undo the screws on both sides using a star hexagonal socket screwdriver and remove the handle with the handle caps.





3.5 Replacing the lock.


Undo the screws on both sides using a star hexagonal socket screwdriver and remove the handle with the handle caps.



Slide the new lock onto the handle tube. Insert the two handle cap elements into one another.




Affix the caps to the sides of the handle. Secure the lock with the screw.





3.6 Replacing the bumpers.

When applying a new bumper, first slide the plastic bumper fully onto the wire base frame. Then guide the rack into the upper groove of the bumper.



Then fit the fixture clips and hammer into place with a soft-headed hammer.



Replacements may only be carried out by service partners authorised by Geck.



3.7 Replacing the child seat.

Slide the child seat through the opening in the baby-child seat flap and press onto the appropriate wire.



3.8 Replacing the flap stoppers.

Open the flap stoppers by hand.



4 Putting into use

4.1 Notes - Putting into use

- Check each shopping trolley for damages before making it available to customers
- Instruct your personnel
 in the safe use of the shopping trolley
 about the instruction of end customers
- For hygienic reasons, only park the trolleys in covered locations, e.g. parking boxes.
- Ensure that the shop furnishings are designed in such a way that the shopping trolley does
 not cause damages for example, the use of bumpers at the cash desks which are suited to
 the trolley type being used.
- Inform your customers by means of notices about the correct use of the shopping trolleys in park boxes, the store and on the moving pavement/ramp.
- Modified or defective trolleys must be immediately removed from use.

Inspection of the shopping trolley suitable for use on personnel moving pavement/ramps:

Inspections and functional checks should be carried out by a competent person on the moving pavement/ramp on which the shopping trolley is to be used. The check should include:

- A general visual inspection of the moving pavement/ramp, in particular with a view to broken comb teeth and dirt.
- A general visual inspection of the shopping trolley.
- The effectiveness of the holding mechanisms for loaded and unloaded shopping trolleys on moving pavements/ramps.
- The effectiveness of the holding mechanisms for loaded and unloaded shopping trolleys when the emergency stop mechanism has been activated.
- The checking of the ability of loaded and unloaded shopping trolleys to enter and leave the moving pavement/ramp.
- Inspections and acceptance tests on delivery should be repeated after larger changes.

4.2 Providing the shopping trolley for use

Providing the shopping trolley without deposit system

 Slide the shopping trolleys together to form lines, for example, in the parking box or the line starting station.

5 Operation

5.1 Shopping trolley with child seat

- Decouple the last trolley of the line with the deposit coin.
- Unfold the child seat.
- Fold the goods compartment flap down if need be.
- Seat a small child only up to the maximum specified weight. In most cases, the maximum weight is 15 kg, but this may deviate according to the trolley type. Pay attention to the seat plate print.
- Apply the safety belt, if available.

5.2 Shopping trolley with baby seat and babysafe



5.2.1 Baby seat

- Decouple the last trolley of the line with the deposit coin.
- Pay attention to the safety notes on the baby seat.
- If need be, use the castor brake to secure the trolley.
- Lay the baby (maximum of 9 kg) in the seat.
- Close the safety belts and adjust.
- Do not leave the baby unattended in the shopping trolley.
- Do not use the shopping trolley with baby seat on escalators or conveyors.
- Only use shopping trolleys on moving pavement/ramps which have been authorised specially for moving pavement/ramps.

5.2.2 Babysafe holder

- Pay attention to the safety notes on the babysafe holder.
- After placing the babysafe onto the holder, fix it carefully with the belt.
- If need be, use the castor brake to secure the trolley.
- Never leave your baby unattended in the trolley.
- Do not use trolleys with babysafe on moving pavements or escalators.
- Before putting the trolley back , take the babysafe with your baby out of the holder.

5.3 Shopping trolley on moving pavement/ramp

- For moving pavements/ramps, special shopping trolleys with pavement/ramp castors are used. These are precisely coordinated for the pavement/ramp.
- Observe the chapters 1.3 and 1.4 as well as the safety regulations and the operating manual of the conveyor manufacturer.

The overall responsibility for safe use in accordance with the applicable laws and standards of Geck shopping trolleys is solely that of the operator of the pavement/ramp.

Technical requirement for the use of shopping trolleys on moving pavements/ramps: According to EN 115:1995, 0.5.3:

- Maximum nominal speed: 0.5 m/seconds
- Angle of tilt of the comb teeth in reference to the conveyor or the pallet step surface: $\beta \leq 15^o$
- Height between the conveyor or the pallet step surface and the floor: $H \le 55$ mm
- Distance between the height of the conveyor or the pallet step surface at the level of the comb intersection and the connection to the floor: L ≥ 500 mm

6 Maintenance

6.1 Cleaning

- **Caution**: Ingression of spray water contamination causes rust formation in the inner of the tubes.
- When using the pressure cleaner to clean, do not directly spray the drilled holes and the notches on the tube connections!
- When using the pressure cleaner to clean, do not directly spray the coin or key slots.
- Do not spray into the mechanics!
- Do not use aggressive scourers and cleaning agents.
- Only use the original GITC Geck cleaning agent.
- A work instruction for the cleaning of Geck shopping trolleys has been included in this manual.

6.2 Inspecting the shopping trolley

- Carry out daily visual checks and have any damaged trolleys repaired or take these out of operation.
- At least twice a year, carry out a comprehensive inspection of all shopping trolleys.
 Document this inspection in writing in the check book using the checklist from chapter 7.

6.3 Checks

- Check for even floor contact of the castors.
- Check that the castors move freely.
- Check that the castors are firmly secured.
- Check the shopping trolley for deformation and damage.
- Check the shopping trolley for breaks and loose outstanding wires.
- Check the shopping trolley for functionality.



6.4 Inspection of the shopping trolley suitable for use on personnel moving pavement/ramps

Inspections and acceptance tests on delivery (see 3.2) should be repeated after larger changes.

Larger changes are:

- For the moving pavement/ramp: See EN 115:1995, 16.2.2 "Check after major changes"
- For the shopping trolley: Construction changes; use of parts or accessories that are not original parts, in particular when replacing castors or bracket mechanisms, in order to hold the shopping trolleys in a locked position.

Note: The replacement of parts with parts with the same construction is not considered a major change.

Regular inspections and checks according to 3.2 should be carried out at least every 6 months. These should include the state of the castors of all shopping trolleys.

The interplay between the moving pavement/ramp and the shopping trolley should be recorded at the latest as of the first use of the shopping trolley.

An inspection book should be updated and maintained by a competent safety officer and contain the following:

- recording of the date of the first use of the shopping trolley and data, in particular, the permitted overall load, larger changes and replacement parts exchange;
- reports with dates regarding checks, inspections, maintenance and checks, in conjunction with comments as well as reports about all accidents.

This inspection book must be made available to the maintenance department and the safety officer (the national authority may specify according to regulations, who is responsible for the inspection book).

7. Checklist for shopping trolleys

- ! Copy the next page, fill out and file with the test protocols.
- ! Carry out checks every six months of the shopping trolley and an entry check when taking it into commission.
- ! These checks must be carried out!

1. CHARACTERISTIC

Liquid, almost neutral product for the cleaning of shopping trolleys. A high proportion of effective surfaceactive ingredients lend the **Geck Intensive Trolley Cleaner** its pronounced cleaning properties.

Even heavily greased surfaces are cleaned gently. Care components result in light oiling, for example, the clean surfaces are coated with a hydrophobic film which lends the materials gloss, a certain level of corrosion protection and prevents fast recontamination.

The coated, varnished surfaces, as well as aluminium and other sensitive metals are not attacked. Important content: Tensides, amine, scent and corrosion inhibitors.
